We enclosed herewith "Master Circular on Schedule of Charges" issued vide BRPD Circular No.07, dated October 31, 2019 by Banking Regulation and Policy Department, Bangladesh Bank, Dhaka regarding Account Maintenance Fee on Savings and Current Accounts.

In line of above circular, Account Maintenance Fee on Savings and Current Accounts are prescribed bellow with immediate effect.

1. There will be no Account Maintenance Fee on Savings Account(s) having Average Balance below BDT 10,000.00.
2. Account Maintenance Fee will be as followed on half-yearly basis on Average Balance of Savings Account (s):

| Sl. No. | Average Balance | Maximum Account Maintenance Charges |
|---------|-------------------------------------|-------------------------------------|
| 1. | BDT. 10,001.00 - BDT. 25000.00 | BDT. 100.00 |
| 2. | BDT. 25,001.00 - BDT. 200,000.00 | BDT. 200.00 |
| 3. | BDT. 200,001.00 - BDT. 10,00,000.00 | BDT. 250.00 |
| 4. | BDT. 10,00,001.00 & Above | BDT. 300.00 |

3. Account Maintenance Fee on Current Account will be maximum BDT. 300.00 on half-yearly basis.

Also, other fee will remain unchanged as per BRPD Circular No. 19, dated December 22, 2009 (enclosed) herewith.
